6. The quotation shall not contain corrections, erasers and overwriting, it will result in rejection of quotation straightway.
7. The KVK reserves all the rights to accept or reject any/all quotation(s) and to increase or decrease quantity or configuration of items specified without specifying any reason.
8. Above mentioned Quantities are tentative and can be increased/ decreased to any extent or can be total totally omitted according to sanctioned amount & the firm will have no claim on this account.
